## MESSAGE FROM MAYOR RICK CROSS:

## **COVID-19 Update**

In my November 24th message, I shared that, given the continued increases in COVID-19 cases across the state and our community, Governor Cooper



expanded the state's mask mandate. The state also implemented a <u>County Alert</u> <u>System</u>, which is intended to better understand the spread at a local level, and help us better address how to best use our resources - where we need to increase our efforts toward education, testing, and contact-tracing.

There continues to be concern that, although our state had not been seeing the surge that many other states were experiencing, we are now seeing numbers of COVID-19 cases, related hospitalizations, and percent positives vs tests increasing to all-time highs across our state and community.

This week, in response to continued increases in the above numbers, the Governor has issued **Executive Order 181**. This order, which will be in effect between December 11 at 5:00pm and January 8, 2021, at 5:00pm, extends the current Phase 3 requirements outlined in Executive Order 180, and takes additional steps, which includes the following:

- Certain businesses must close between 10:00pm and 5:00am This includes restaurants (except for take-out and delivery), bars, and others as listed in the Executive Order.
- Sale and service of alcoholic beverages is prohibited for on-site consumption between the hours of 9:00pm and 7:00am.
- A modified "Stay at Home" order between 10:00pm and 5:00am.

Since the initial County Alert System report, Davie County has moved from RED to ORANGE due largely to the reduction in percent positive cases vs. testing over the past 14 days (from 12.2 to 9.5%). It is important to note that recent daily rates have been over 11%, and we are still seeing a high number of COVID-19 cases across our community.

Across the state, numbers of RED (48) and ORANGE (34) counties have increased and now represents 82 of our state's 100 counties.

This week, our state also began sharing the **NC COVID-19 Vaccine Plan**. In my communications with Davie County Health and Human Services Director Suzanne

Wright, she shared the following:

"We (public health leadership) learned last week that vaccine shipments to most local health departments could happen as early as December 21, 2020. Once vaccine is received for Phase I, we will work to vaccinate local healthcare workers (as determined by CDC and NCDHHS). The first shipments will go to hospitals, long term care facilities and local health departments. We will be meeting with those in Phase I of the COVID-19 vaccination plan next week."

We continue to work alongside our county officials and staff to take steps to manage the impact of COVID-19 across our county. These folks, our medical personnel, first responders, and all others who continue to be there for us every day have been tireless in their efforts during these past 9 months.

Please join me in keeping them in our thoughts, and remember that as we move through this holiday season, our continued commitment to the **3Ws** - **W**ear, **W**ait, **W**ash - is the thing that each of us can do to reduce risk and potential impact of COVID-19 in our community.
