A. Comprehensive Plan Comments/Update

Updated draft was sent to the Council on Friday, February 24. Plans are to present at the March Council Meeting.

B. Powell Bill Funds

NC DOT letter stating the Town of Bermuda Run was in violation of state law by holding on to funds for larger projects. Town Manager Meadwell asked for exception to bank up to 20 allocations and the request was approved.

C. House Bill 95

\$5.9 Million for projects for the Town of Bermuda Run were submitted by Representative Julia Howard and Representatives Crutchfield (Rowan/Cabarrus), White (Johnson), and Zenger (Forsyth). Projects included were Stormwater, drainage, and flooding enhancements; wayfinding signage and Memorial Flag project; Phases II and III of Blue Heron Trail; Yadkin River Blue Water Trail Access Head at Truist Park; pedestrian interconnectivity to Atrium/WFBH Davie Medical Center; development of Farmers Market at Town Green.

D. Traffic Impact Analysis

Criteria for new development to help look out for residents that would be conducted by traffic engineer such as Stimmel. Interconnection with NC DOT.
