**1. Call to Order**

*Mayor Kenneth Rethmeier called the meeting to order.*

**2. Adoption of the Agenda**

*Council Member John Guglielmi made a motion to adopt the agenda with Council Member Jerry West seconding the motion. The motion was approved by a vote of five (5) in favor and none opposed.*

*Council Member Mike Ernst made a motion to approve the June 25, 2019 Agenda Meeting minutes. Council Member Chris Fowler seconded the motion. The motion was approved by a vote of five (5) in favor and none opposed.*

**5. Items for Consideration**

**A. Community Officer Update**

Sheriff JD Hartman provided detailed data regarding activity within the Town of Bermuda Run. The Davie Medical center is the highest response area, followed by the shopping centers with a wide range of activities. There was more discussion regarding underage drivers on golf carts, and Officer Robertson shared that most of the time the parents are on the carts with them. The Council praised Officer Robertson for his building of community relations, saying that just his presence has a positive impact.

**B. Zoning Map Amendment**

Bob Hodges has applied to rezone a 2.55-acre tract of land from Residential Mixed (RM) to Commercial Mixed (CM). The subject property is located north of 169 Yadkin Valley Road. The applicant owns the adjoining property to the south. The Planning Board unanimously recommended approval of the proposed rezoning at their July 17, 2019 meeting.

*Council Member Jerry West made a motion to hold a Public Hearing to consider the zoning map amendment at the August 13, 2019 Town Council Meeting. Council Member John Guglielmi seconded the motion. The motion was approved by a vote of five (5) in favor and none opposed.*

6. Information Items

A. Information Concerning Appointments of Mayor and Town Council Members

Mayor Rethmeier's last meeting will be the August Council Agenda Meeting due to moving out of town. He plans to provide a public statement for release around August 15. He recommends that John Guglielmi step in as Interim Mayor until after the election and the start of the newly elected Mayor's term.

B. Ignite Davie Brochure

The Council has been asked to consider a contribution from the Town for the "Ignite Davie" program that begins in Senior High. Council Member Jerry West shared that this would help the Town of Bermuda Run achieve connectivity with the rest of Davie County and would make a nice statement. Council Member Mike Ernst has been involved with "Davie Scholars" program that begins in 6<sup>th</sup> grade; and he has met with the school Superintendent as well as others regarding how the two programs can compliment each other.

*It was agreed that the Council will take action at the August 13 Council Meeting regarding amount of money to contribute on behalf of the Town.*

Mike Ernst – Asked for clarification as to whether the trees along Ivy Circle/Hwy 801 would be replaced. (Lee Rollins has suggested that they be replaced with ivy.)

John Guglielmi – Thanked the Council for their support of the Mayor's suggestion for him to be Interim Mayor.

Jerry West – Asked if anyone knew the new candidates for Council (Heather Coleman / Curtis Capps).


