B. Gate Operations Fund Proposal – Replanting of the NC 801 Fence Line at Ivy Circle

Blakley Landscaping Services has provided a proposal to plant 115 Emerald Green Arborvitae trees at six (6) foot high. The proposed cost is \$31,250. A budget amendment to the Gate Operations Fund will be needed if the Council approves the proposal. The current fund balance for the Gate Operations Fund is \$223,537.

Council Member Jerry West made a motion to approve the proposal. Council Member Chris Fowler seconded the motion. The motion was approved by a vote of three (3) in favor and none opposed.

C. Blue Heron Trail Local Project Agreement with NCDOT

The Project Agreement with NCDOT reflects the scope of work, funding and schedule that has been programmed into the State Transportation Improvement Program by the Winston-Salem Metropolitan Planning Organization (MPO).

Council Member Jerry West made a motion to approve the proposal as presented. Council Member Rick Cross seconded the motion. The motion was approved by a vote of three (3) in favor and none opposed.

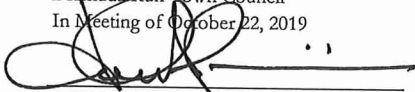

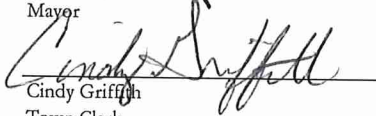
