The PTRC is a voluntary association of local governments, urban and rural. It acts as a division of local government and is governed by a Board of Delegates and an Executive Committee. The Board of Delegates meets quarterly on the last Wednesday of the month. Most meetings are lunch meetings. Mayor Cross is the current delegate representing the Town.

Council Member Melinda Szeliga made a motion to appoint Mike Brannon as delegate to the Piedmont Triad Regional Council. Council Member Heather Coleman seconded the motion. The motion was approved by a vote of five (5) in favor and none opposed.

C. Appoint Mike Brannon to Davie County Economic Development Commission Representing the Town of Bermuda Run

The purpose of the Davie County Economic Development Commission is to function as an advisory Board to the Davie County Board of Commissioners and Elected Municipal Boards in the formulation of formal recommendations as to goals and objectives for the overall economic development of Davie County. Mayor Cross and the Town Manager currently represent the Town on the Commission. Council Member Mike Ernst made a motion to appoint Mike Brannon to the Davie County Economic Development Commission. Council Member Heather Coleman seconded the motion. The motion was approved by a vote of five (5) in favor and none opposed.
