Presentations

a. Gale Hanser, Davie Respect Initiative

Ms. Hanser shared background and information about the program stating that it was in its 7th year. Ambassadors Shaun Lane, Ava Brown, and Sylas Johnson shared their experiences with the Davie Respect Initiative. Key points – "renewed hope for the future", "developing leaders of tomorrow", "putting thoughts into actions".

Action Items

A. Addendum to Davie County Sheriff's Office (DCSO) Law Enforcement Services Agreement, Equipment.

Council Member Jeff Tedder made a motion to approve the addendum as presented. Council Member Christy Schafer seconded the motion. The motion was approved by a vote of four (4) in favor and none opposed.

B. Resolution Accepting Street Rights of Way into Public Street System

Staff is requesting that the rights of way of the northern unnamed street be accepted into Town's Public Street System. Northern stub of E. Kinderton Way – allowing Phase II of the Blue Heron Trail (connection to the I-40 pedestrian bridge).

Council Member Mike Ernst made a motion to approve the resolution as presented. Council Member Rae Nelson seconded the motion. The motion was approved by a vote of four (4) in favor and none opposed.

Update regarding pedestrian pathway in BR East – resident input planned for January, 2025. 4th Annual *Christmas in Bermuda Run* scheduled for Sunday, Dec. 8 from 2 – 5 pm. Presentation at Shady Grove Elementary School – 3rd graders. Council tour of the Davie County Sheriff's Department on November 11. Jayman Gaddy of the Davie County Tax Office scheduled to make a presentation at the December Council Meeting.

Overview:

The Town of Bermuda Run has received a grant from the Davie Community Foundation in the amount of \$12,000.00. These funds were provided from funds within the Bermuda Run Community Vision Fund.

The Bermuda Run Community Vision Fund Committee requested the funds to offset initial costs of planning and implementing the "Christmas in the Town of Bermuda Run" event. The 2024-2025 adopted Town Budget did not include this revenue and subsequent expenditures.

I recommend the Town Council take action to amend the current 2024-2025 General Fund Budget to receive \$12,000.00 from the Davie Community Foundation as revenue and subsequent \$12,000.00 in expenditures for expenses related to the "Christmas in the Town of Bermuda Run" event, coordinated by the Bermuda Run Community Vision Fund Committee.
